- 8. Identify any/all methods of source of heating the pool. Location of propane tank, and solar panels, or sources for example.
- 9. Identify location of all pool equipment, filters, heating etc. are to be located within the fenced area of the pool. All equipment must be shielded from roadway or neighbors on a year round basis.

- 10. If a shed is part of the project, a separate shed application is required.
- 11. Resident/applicant must notify all neighbors within 200 feet of the property lines by Certified Mail of the proposed pool project (copy of survey to show all details and location of project.).
- 12. Does the pool, including fence, patio and pool surround meet the Smoke Rise Club property line setback(s): 50 feet side and rear. If not, additional variance will be required by the Kinnelon Board of Adjustment.
- 13. A member of the AVC will contact resident to visit the property to take a picture of the proposed location of the pool on the property. Picture to be attached to file.
- 14. Any and all external changes in the project must be provided to the AVC for approval. Failure to do so will result in a stop work order.
- 15. NOTE: Purchased water for pool test and fill <u>is not</u> allowed into the Smoke Rise Community before 8 am or after 6 pm Monday through Saturday and <u>not at all</u> on Sunday. Please make sure that your contractor is informed of this.
