SPEND YOUR MONEY WITHOUT GIVING YOU A SAY IN HOW IT'S SPENT.**

**PLEASE PLAN TO ATTEND THE MEETING AND DEMAND COMPLETE
ANSWERS TO THE FOLLOWING IMPORTANT QUESTIONS:**

**1. ASK HOW MUCH DPWA BOARD MEMBERS SPENT TO HIRE AN

TWO JERSEY CITY OFFICIALS INDICATED
HIRING THEM WAS UNNECESSARY?**

**3. ASK WHY NO ACTION HAS BEEN TAKEN ON THE NOV. 2011

FROM SPEARHEADING THE SEARCH?**

**4. ASK WHY AFTER FIVE MONTHS THE DPWA BOARD STILL HAS NOT

AGREEMENT THAT WOULD ALLOW SH I AND SH2 RESIDENTS TO
PARTICIPATE ON THE FINANCE COMMITTEE? ASK WHY TO DATE
ONLY DROYERS POINT RESIDENTS ARE SERVING
ON THE DPWA FINANCE COMMITTEE?**
